 - i. Comment: Students can use this policy as a basis for a grade appeal.
 - ii. Comment: This policy does not distinguish between courses that require midterm feedback and those that do not.

- iii. Question: Is there any required action beyond making a best effort? Is this policy simply suggesting a best practice?
 - iv. Answer (Vice-Chair): Yes.

- 4. **MOTION 2526.FAPC.003.P GCSU FACULTY PROFESSIONAL LEAVE POLICY REVISIONS** On behalf of the committee, Sabrina Hom, FAPC Vice-Chair, presented the motion “The Faculty Affairs Policy Committee moves that the University Senate approve the revisions to the Faculty Professional Leave Policy and associated application materials as circulated.”

 - b. **CONTEXTUAL INFORMATION** The policy revision simplifies and clarifies language that does not conform to USG policy, changes the faculty return to service as one year after one semester leave and two years a two semesters leave, removes seniority from the procedures because of different interpretations of seniority’s meaning (a majority of faculty in a survey revealed that seniority and rank should not be taken into account in procedures).
 - c. **DISCUSSION** When Sabrina Hom called for questions and comments, many were forthcoming.
 - i. Comment: The document on the Academic Affairs website dated 2006 does not align with the PPPM.
 - ii. Question: These questions are not about the motion but rather about Professional Leave inequities on the one hand and faculty rights and responsibilities on the other. Professional leave is granted in part based upon the needs of the academic unit. If a faculty member has expertise that cannot be replaced, how can inequities be addressed? Are faculty members allowed to vote on important faculty issues during professional leave?
 - iii. Answer (Vice-Chair): Those are good questions for FAPC to address.
 - iv. Comment (Provost); Equity is a concern that I shared, especially from Nursing and Education, which have student cohorts that cause faculty to feel like they can’t apply for professional leave. I’m thankful to remove “seniority” because it’s meaning is unclear. Professional leave is a costly endeavor for the institution and a privilege for us to grant.
 - v. Comment: If there are academic units with faculty who are not easily replaceable for professional leave, then they are also not easily replaceable in the event of personal tragedy. All academic units should maintain continuous planning for faculty leave.
 - d. **SENATE ACTION**
 - i. Motion 2526.FAPC.003.P was **APPROVED** by voice vote with no additional discussion and with no dissenting voice and only faculty senators eligible to vote.

PRESIDENT’S REPORT — PRESIDENT CATHY COX

1. **LEGISLATIVE UPDATE**

- a. I reported to you in February on the success we had in the state's amended FY26 budget (\$5 million in renovation funds for A&S building, \$2K bonus for state employees), but today, with only two days left in the legislative session, we have been dealing with a very different situation. Today, the Georgia Senate passed its version of the FY27 budget and included a surprise cut of \$123 million to the University System of Georgia – which may be the largest proposed cut in the history of the USG outside of the Great Recession.
 - b. The reason for the cut? The Appropriations Chairman said he believed that online instruction costs less than in-person instruction and now that some 30% of the USG's credit hours are earned through online instruction, he therefore proposed a cut based on a formula he devised that said every 1.1 hour of online instruction should cost the same as 1.0 hours of in-person instruction. Based on that formula – he had sought no data from the USG on actual costs of online instruction compared to in-person instruction – he proposed the cut of more than \$123 million to the system. When that amount is prorated out to each USG institution based on the number of online credit hours of instruction they offered, it means that Georgia College would lose \$1.8 million.
 - c. The range of cuts throughout the USG ranged from the high of \$27 million to Georgia Tech, \$16 million at KSU, \$14 million at Georgia State, and on down the line to ABAC, with the lowest proposed cut of just under \$500,000.
 - d. We've been working hard over the past 36 hours to contact legislators and present the impact of this cut. It will surely be debated in a conference committee of the House and Senate and the Governor's office over the weekend and into next week, when they must pass the final version of the budget before adjournment on Thursday. So – stay tuned for the final result next week. A cut to GCSU of \$1.8 million is not something we have the ability to absorb or cover, so we are hopeful the funds will be restored in the conference committee.
2. **BOARD OF REGENTS/USG UPDATE** The Board of Regents held its annual planning retreat during the month of March, so there is no regular meeting activity on which to report.
3. **PROMOTION AND TENURE** The Provost has shared with me the portfolios of 21 faculty candidates for Promotion and Tenure. Five Faculty have submitted applications for tenure, and as in years past, I will be meeting with all those who are recommended for tenure, as this is such an important stage in the career of a faculty member and in the life of the university. Next week, I have meetings scheduled with those who are eligible for tenure, and I am looking forward to these conversations! So, we will have more to report on all the candidates for promotion and tenure at the April meeting of the Senate.

PROVOST'S REPORT — PROVOST HOLLEY ROBERTS

1. **PROVOST'S OFFICE UPDATES**

a. **RESEARCH DAY** GCSU's 4th Annual **Research Day** will be on **April 15th, 2026**.
**Classes will be reassigned so all can join this campus-wide celebration of student
success.**

i. This year, Research Day will feature **286** student projects, presented by
both undergraduate and graduate students, a **13%** increase from 2025.
Presentations will begin with poster sessions in the morning and continue
with concurrent oral presentation sessions throughout the day.

ii. Research Day will kick off on April 14th with the Saladin Scholar Award
Ceremony & Keynote Address, featuring Dr. Scott Huettel from Duke
University

iii. Students will also have the chance to participate in various special events
on Research Day, including the GC Journeys Showcase, Women's &
Gender Symposium, First-Year Writers' Showcase, 3-in-3 Competition,
Writing Center Poster Competition, Digital Humanities presentations, and
Lunch on front campus.

b. **FRESHMAN CLASS OF 2026 UPDATES** As of March 27, 2026 we have received a
record number of applications at 9,680 which is a new record and is 16% more
than at this time last year! We currently have 7,100 completed applications, 5,026
admits, 1,684 student deposits, and 1,602 potential freshman who have paid their
housing deposit.

c. **SUMMER ENROLLMENT 2026** As of March 22, 2026, summer enrollment is down
overall by approximately 3% in comparison to this time last year, with a 2%

decrease in overall credit hour production. The decrease is mainly in graduate enrollment. Fall overall enrollment is showing a modest increase of nearly 3%.

- d. **NEW FACULTY POSITIONS** In collaboration with Budget and Finance, the Provost's office has approved 12 new faculty positions for FY 27 (6 Tenure track, 6 Lecturer) to support student needs in the COAS, COBT, COHS, and COE for fall 2026.
 - e. **COLLEGE OF EDUCATION DEAN SEARCH** A national search for the next dean of the John H. Lounsbury College of Education has begun and is supported by the search firm, Academic Search. The search co-chairs are Dr. Indiren Pillay and Dr. Lyndall Muschell. Applications will be received through March 29, 2026. Nominations can be submitted directly to the search firm via GCSUDEanEd@academicsearch.org. The new dean will start on July 1, 2026. Please plan to participate in the activities related to the campus visits that are tentatively scheduled to occur on April 7-8,9-10,20-21,23-24.
 - f. **NATIONAL INSTITUTE FOR STUDENT SUCCESS** Georgia College, as with all other USG institutions, has engaged with the National Institute for Student Success (NISS) at Georgia State University focused on student success initiatives. - a. **ACADEMIC FEEDBACK POLICY** The APC voted to adopt a revision to the Academic Feedback Policy to align with USG language and articulate our institutional commitment to timely, useful feedback.
 - i. "At the beginning of each course, faculty must clearly define for students the basis on which grades will be determined through written notification in the syllabus. In addition, they must provide timely academic feedback as the course progresses. This could include the following:
 1. Prior to midpoint of the total grading period, all assigned and "turned in" graded class assignments and examinations should be graded and available to the student.

2. The instructor and student should make every effort to be available during instructor's office hours for discussion of the student's academic standing prior to the midpoint of the total grading period (particularly for classes that use subjective grading)."
- b. **DISTANCE EDUCATION POLICY: REGULAR AND SUBSTANTIVE FEEDBACK** The APC voted to adopt a proposed addendum to the Distance Education Policy. The approved addendum is as follows:
 - i. "Regular and Substantive Interaction (RSI)"
 1. The U.S. Department of Education mandates that all online courses and programs include regular and substantive interaction between students and their instructors.
 - ii. **Regular Interaction:**
 1. In learning environments of any kind, regular and substantive interactions must be:
 2. With an instructor as defined by the institution's accreditor.
 3. Initiated by the instructor.
 4. Scheduled and predictable.
 5. Academic in nature and relevant to the course
 - iii. **Substantive Interaction:**
 1. Substantive interaction is defined as engaging students in teaching, learning, and assessment, and must include at least two of the following:
 - a. Provide direct instruction
 - b. Assessing or providing feedback on a student's coursework
 - c. Providing information or responding to questions about the content of a course or competency
 - d. Facilitating a group discussion regarding the content of a course or competency"
- c. **COURSE WITHDRAWAL POLICY** The APC voted to approve an amended Course Withdrawal Policy.
 - i. "A student may drop courses from their schedule with no penalty through the last day to drop without penalty as published in the Academic Calendar for each term or part of term. Students with an advisor hold must obtain approval from their academic advisor to drop a class; no additional approvals are required during this period. Courses dropped during this period do not receive a W grade, do not count in the student's attempted hours and do not appear on the academic transcript. Students will not be charged tuition and fees for courses dropped during this period as long as they remain enrolled in other courses for that term or part of term.
 - ii. After the last day to drop a course with no fee penalty and with no W, but on or before the last day of class of each term or part of term, students may drop courses online via MyGCSU/PAWS or by submitting an Add/Drop Card (Course Change Card) to the Registrar's Office. Approval of the academic advisor (if an advisor hold exists) is required. No other approvals are required. Students will receive a W grade for courses dropped during this time period. Courses dropped during this time will count in the student's attempted hours, which will affect the student's financial aid and HOPE eligibility. They will also appear on the academic transcript. No refunds will be issued for

individual courses dropped during this period. Students may not drop courses during this period if they have previously been assigned a grade of F for excessive absences by their instructor or have been assigned an F for disciplinary reasons.”

- a. **DISABILITY TRAINING** In its March 6, 2026 meeting, BIPC continued its discussion of the implementation of the employee training previously recommended by the GCSU Student Disability Resource Center. Since implementation in department meetings will require the active cooperation of department chairs, BIPC member Nancy Mizelle will, with the help of Mike Martino, design a survey that will go out to Department Chairs to assess the latter group’s ideas and concerns. Since BIPC’s discussion of this issue is an advisory issue that will most likely not require any formal policy recommendations, Chair Hedy Fraunhofer sent an advisory memo to the SDRC informing the Student Resource Center of BIPC’s recommendations and ongoing developments concerning this issue. We recommend that the SDRC send the list of available Vector training modules to Nancy Mizelle and Mike Martino so that they can share it with the Council of Chairs. CTL Director Jim Berger has recommended implementation in Fall 2026 (which could coincide with Disability Awareness Month in October), since CTL is busy with implementing the new WebContent Accessibility Guidelines (WCAG 2.1 Level AA) this April.

- b. **CIVILITY AND COLLABORATIVE EFFECTIVENESS POLICY** BIPC then moved on to a longer discussion of a proposal by BIPC member and GCSU Humans Resources Director Eric Johansen for a new university-wide Civility and Collaborative Effectiveness Policy. As part of his presentation, Eric referenced other universities and university systems nation-wide that already have similar policies on the books. BIPC discussed at length potential benefits of such a policy, as well as concerns, such as cultural prescriptiveness. As part of this discussion, BIPC noted that GCSU does not currently have an anti-bullying policy. Committee members decided to continue this discussion during their next meeting in April.

- b. This memorandum summarizes proposed DNP program catalog revisions, which include the removal of courses that are no longer utilized and updates to course descriptions and pre/co-requisites to ensure appropriate curriculum sequencing and full alignment with the current programs of study. These revisions do not alter the existing program of study, course alignments, or degree requirements.
- c. Modified Courses: NRSB 8300, 8410, 9300, 9310, 9320, 9400
- d. Deleted Courses: NRSB 8520, 8530, 8540, 9100
- e. Updated Course Descriptions: Emphasize progression and integration across sequenced courses, particularly in Evidence-Based Practice (NRSB 8300, 9300, 9400) and Translational and Clinical Research (NRSB 9310, 9320).
- f. These revisions are proposed for implementation in Summer 2026 and support program integrity, accreditation compliance, and optimal student outcomes.

iii. Update from Each College

1. College of Arts & Sciences

- a. Some proposals are expected to come forward, including a pilot for 8-week session models to evaluate how the format performs and whether it may increase competitiveness.
- b. Kay A. noted that this change would have broader implications, including considerations around Double Bobcats, financial aid, and other operational areas.
- c. Program length changes are also part of the discussion, with more conversations to come as details develop.

2. **College of Business & Technology**

- c. Further conversation is needed because the two programs differ in delivery format—some courses are fully online while others are offered on campus.
- d. This may result in students beginning with face-to-face coursework and transitioning to online courses as they complete the program.
- e. The proposed dual program would total 45 credit hours across both degrees.
- f. More details and discussion will follow as the proposal develops.

- c. A meeting with the **Montori School** is scheduled, where additional possibilities for program development and recruitment partnerships will be discussed.

- a. Modify the title of GC2Y “Theatre for Social Change” to “Theatre and the Public Sphere” (approved via email on 2/6/26)

Modify the section description to: Theatre and the Public Sphere examines how theatre has historically provided a space for communities to express ideas, debate issues, and reflect on shared experiences. Open to all students, regardless of prior theatre experience, this course combines performance analysis, historical research, and creative exercises to explore how theatre connects to public conversations across time and cultures. Through studying archival stories, oral histories, plays from around the world, documentaries, and community narratives, students will investigate how theatre functions as a mirror of society — a place where stories, traditions, and questions about identity, belonging, and change are explored. Working individually and collaboratively, students will engage in research, creative group exercises, and improvisational projects that link performance to public dialogue. The course encourages students to think critically about how theatre shapes the way communities understand themselves and each other, both locally and globally. (approved via email on 2/6/26)
