Following up on suggestion of required faculty training (e.g. on learning accommodations) - Feedback received. Possible informal survey of departmental faculty/constituents concerning required or optional training? The committee thinks this kind of training is desirable but perhaps there's a kind of "training fatigue" given the required annual training. It was suggested (Nancy) that we reach out to the Council of Chairs on the possibility of this being implemented by chairs at department level. Training in cross-cultural communication? There is need for training in crosscultural communication for faculty/staff, similar to what is available to students in certain classes. The idea is to help people understand differences in styles of communications due to cultural differences as these often result in misunderstandings. Issue not resolved. These kinds of conversations could also happen at departmental level.

Personal experiences at GCSU? Do faculty/staff feel supported? 1) Michael – there are efforts on campus to host events that bring people together but the sense of support (or not) depends on individuals' level of involvement in those activities (e.g. fall fest on front campus the previous week). 2) Sometimes the events don't cater to all needs, for example, a lack of vegan options at the post-convocation picnic. An improved vegan option was available at Fallfest. 3) Having leaders (department chairs) who are approachable, and that people feel comfortable reaching out to with concerns, matters. Example, Nancy's department when surveyed seemed satisfied. 4) Support at the system level could be improved, for example, ensuring that the vendors chosen by the system to handle healthcare matters are professional and fair. 5) Greater support seems desirable for faculty who want to ensure student integrity and success in classes, involving especially students' unauthorized use of AI in assignments (a nation-wide professional concern).

Physical access to campus buildings - The concern was whether all campus buildings were accessible. It was discussed and agreed that the facilities office Nancy will speak with the COE representative on the Council of Chairs and get back to us.

- 4) Eric will relay feedback about some negative experiences to the system office.
- 5) It was suggested that we talk to Jennifer Graham, Associate Dean of Student for Student Integrity and Success, and CETL about this issue (Laura will follow up).

Michael will talk to them about the campus master plan and any planned improvements. At the
