Academic Calendar Issue In response to a procedural question raised by faculty, Provost Roberts, Vice President Nadler, and Dean Goette explained that the committee typically meets in the spring but met in September this year. The committee's calendar recommendation is reviewed by the Provost and Executive Cabinet; and the calendar is changed along the way. It was suggested that since this faculty question appeared to involve transparency of process, senators serving on university-wide committees could be asked to report their committee's work to Senate on a regular basis. When the conversation turned to classes being held on Tuesday before Thanksgiving, it was suggested that Student Life should remind both students and parents that Tuesday is class day.
- 2. <u>Governance Calendar 2024-2025</u> Alex Blazer shared the draft, which was under review by both the President's Office and Provost's Office.
